## GENERAL INFORMATION

**EnerG Plus** by Ag Performance can be applied as a seed treatment, root dip, soil and foliar application. These various types of application enable the soil and the plant to receive direct benefits from **EnerG Plus**.

**EnerG Plus** is recommended for application on the following crops: Alfalfa, almonds, avocados, apples, bananas, beets, berries, broccoli, brussel sprouts, cabbage, carrots, cauliflower, celery, citrus, clover, coffee, corn, cotton, grain sorghum, grapes, lettuce, melons, okra, peaches, pecans, peppers, potatoes, peanuts, rice, sorghum, soybeans, sugar beets, sweet corn, sugar cane, strawberries, tobacco, tomatoes, watermelons, and wheat.

## DIRECTIONS FOR USE

The following application rates are for general practices. Please consult your Ag Performance representative for a customized crop application.

**Seed Treatment Application:** Apply 6-8oz of EnerG Plus per 50lbs. of seed.

**In-furrow Application:** Apply 16oz. of EnerG Plus per acre at planting with 10oz. per acre of Xylem Plus.

**Broadcast or Band Soil Application:** Apply 16oz. of EnerG Plus per acre prior to planting or plant emergence.

**Foliar Application:** Regular applications of EnerG Plus should be foliar applied up to the boot stage of plant growth at the rate of 16-32oz. per acre. For best results spray when the crop is in an active growing state after irrigation or natural rainfall. Spray early in the morning or late in the afternoon for best leaf absorption. (Foliar fertilization is intended as a supplement to a regular fertilization program and will not, by itself, provide all the nutrients normally required by agricultural crops.)

AS WITH ANY AGRI-CHEMICAL, ALWAYS DO A COMPATIBILITY CHECK TO INSURE PROPER MIXING.

## MIXING INSTRUCTIONS

1. Put 2/3 water or fertilizer in tank.
2. Add correct amount of **EnerG Plus** and **Xylem Plus**.
3. Fill tank with balance of water or fertilizer. Agitate until mixed.

STORE OUT OF DIRECT SUNLIGHT.
